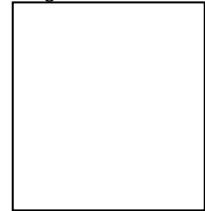
Replacement Cards for Children under 16yrs

In order to have access to the CENTERPOINTE Pool Recreational Area, you will be required to have a valid photo ID card. All homeowners/tenants in need of replacement and/or new cards must use this form. If you are in need of renewals for adults and children over 16, please check the box labeled above. In order to obtain new cards and/or replacement cards, ASSESSMENTS MUST BE PAID IN FULL. New card applicants and all applicants under the age of 16 must furnish the following items:

1. **PHOTO** for each card requested, with the name written on the back.  
(Photos WILL NOT be returned)
2. **EMERGENCY TELEPHONE NUMBER**
3. **SELF-ADDRESSED, POSTAGE -PAID ENVELOPE.**
4. **TENANTS** (Renters) MUST PROVIDE PROOF OF RESIDENCY (i.e. copy of lease or utility bill in your name and Centerpointe address)
